# SUBMISSION GUIDELINES

To ensure a **comprehensive evaluation**, all submissions must adhere to the following guidelines:

## FORMAT AND CONTENT OF SUBMISSION

(Nominations must be formatted as per these specifications)

### 1. General Information

- Name of the nominee / organization
- Complete contact details (postal address, phone, fax, email, mobile)
- Consent for the use of submitted project information, photographs, and logos
- Confirmation of project approval and budget (if applicable)
- Award category selection
- Previous recognitions or citations received

### 2. \*Executive Summary\*

- A **500-word summary** highlighting key achievements, project outcomes, and impact.

### 3. Curriculum Vitae / Team Profile / Company Profile

- A **detailed professional summary (up to four pages)** showcasing educational background, work experience, notable projects, and relevant contributions.



## **FORMAT AND CONTENT OF SUBMISSION (CONTD...)**

### **4. Project Context**

- A brief outline of **programs, projects, or initiatives**, including **purpose, complexity, methodologies, and results achieved**.

### **5. Write-Up**

- A narrative supported by **evidence and case studies** that demonstrate best **practices, management excellence, innovation, and measurable impact**.

## **ENTRY DEADLINE**

- **All nominations must be submitted by 4:00 PM (IST) on June 10, 2025.**

- **Late entries will not be considered.**
